EMF BIO

- In 2008 wrote a legislative bill, The Children's Wireless protection Act, a the first of its kind to be brought in the US calling for brain cancer warning labels on cell phones, requiring hard wired Ethernet internet connection all schools and 1500 foot set back of all cell towers from all schools. The bill was rejected by Washington, but picked up and adapted by a state legislator in Maine in 2009. We then raised funds for the hearing, and we were able to fly in renowned scientists from around the world. We lobbied for 5 years to get the bill past which it finally did in it's 6th year (skipping a year), achieving bi-partisan support with a 2/3 majority vote, meaning the governor would not be able to veto. However, the wireless industry flew in their lobbyists and got the legislators to reverse their votes before the "vote to enact" and thus the bill never became law and the legislator who authored the bill was then "Gerry mandered" out of her district. "Gerry mandering" is when a government agency re-draws the district lines to turn an area from Democrat to Republican or vice versa. In this case the area was turned from Democrat to Republican, forcing the legislator out of her seat...something she was promised by the wireless industry upon her passage of the bill.

Duration: Approximately 6 years

- Started a non profit (2008) and distributed an EMF news letter for the purposes of raising public awareness to the problem of health effects from wireless devices and infrastructures, gave power point presentations to the public and governmental entities and held fund raisers to hire attorneys for our lawsuits to block multiple cell towers in the area and to curtail and raise awareness to the smart meter roll out.

Duration: Ongoing...although I have stopped aggregating news articles on this issue for distribution through our news letter due to time constraints, we still send out the news letter to update people on our activities. We are also still active in the area of organizing lawsuits and studies on this issue, with limited lobbying due to EHS.

- Formed a citizens lobbying group (www.Americanassociationforcellphonesafety.org), went to Washington DC again in 2009 to again lobby for The Children's Wireless Protection Act, but this time the bill only contained more focused language for brain cancer warning labels on cell phones. Here is the video I created for The Children's Wireless Protection Act, the bill calling for brain cancer warning labels on cell phones...

At the request of some of the congressmen and senators we met with, we wrote a letter to the FCC and FDA regarding federal regulatory oversight of radiation emitting devices and infrastructure in the US... http://americanassociationforcellphonesafety.org/uploads/Letter_oF_Inquiry_FCC_Final_7-11-10.doc

Approximately 2 and a half months after this letter was delivered to the FCC and FDA, warnings for children to keep cell phones away from reproductive organs and pregnant women to keep away from unborn fetuses started being placed in Motorola's cell phone manuals, towards the back of the manual.

Duration: Approximately 2 and a half years.

- In 2012, as a result of our meetings with Congress, our citizens lobbying group was asked to consult with the Congressional office that was authoring the letter (backed by 2 other Congressmen including the Chair on the same committee) to the GAO (Government Accountability Office) to ask the FCC to review RF safety standards in the US. We consulted with this Congressional office and once their letter was submitted to the GAO, we then consulted with the GAO on what the GAO's letter to the FCC should include regarding federal regulatory oversight of RF radiation. Although the majority of our comments on non thermal effects from wireless radiation were excluded from the GAO's request for the FCC to re-visit the RF standards, they did include information regarding children and pregnant women, which was a large part of our big push for reform on wireless radiation. The FCC has since took years to address the GAO's request for updating the out dated RF safety standards in the US and recently issued a bill of "good health" to the safety standards, even in the face of the results of the NTP (National Toxicology Program) study showing an increase in 7 different types of cancer including the statement of

“statistically significant carcinogenic effects” with background RF (radio frequency), whole body exposure.

- Organized 2 mass tort lawsuits against the two largest utilities in the state of CA, PG&E and Edison, for health effects from smart meters and smart grid (2012 – 2015). Here is a video interview on the lawsuit. The video had nearly 20,000 views prior to being pulled from You Tube but I posted a copy of a copy of it on one of my You Tube Channels...

Duration: Approximately 3 years.

- In response to the lawsuits, the utility industry’s Congressman/lobbyist filed a bill in Congress to make smart meters and smart Grid mandatory in the US, at which point we organized a national citizens lobbying group to go to Washington, DC <http://www.stopsmartgrid.org/> to block the bill. Through a true bi-partisan effort, the bill was successfully blocked, although full credit for this must be shared with the staff attorneys who were on the committee and found some possible illegalities with the bill. I have included a link to our Congressional White Paper that we wrote and brought to Congress when lobbying against this bill and raising awareness of the issue...

Duration: The group is still in tact but our efforts to block the bill lasted approximately 1 – 2 years. Sever EHS rendered me unable to lobby my government anymore due to the microwave infrastructure in all of the governmental buildings and on the property. However, I have figured out a way now to be in these buildings with wireless signals by wearing shielding.

- Achieved the first free opt out of smart meters with LADWP (approx. 2014). This free opt out remains in effect to this day. You can watch a video on this moment here.

Duration: This effort took approximately less than 1 year but the free opt out is still in effect today.

- Filed multiple lawsuits (2012 – 2016) against the CPUC (California Public Utilities Commission) regarding health effects from smart meters and smart grid.

Duration: This effort lasted approximately 4 years with multiple filings on different aspects of the smart meter issue and various hearings.

- Through the non profit, (approx. 2014) held a fund raiser to hire an attorney and organized the local community to successfully block a major cell tower going up in the middle of our town in Topanga.

Duration: Approximately 1 and a half years.

- Held another fund raiser (2015) to hire an attorney to block another cell tower to go up at the local fire station, however this time it was part of a 150 federally funded

cell tower roll out. Created a video entitled Federal Cell Tower Roll Out in order to raise awareness and help inform people about the issue and stop the roll out...

Organized citizens of LA County with over 100 citizens showing up at the hearing to testify against the massive cell tower rollout along with members of the fire fighters union, to successfully help block the 150 federally funded cell towers going up in LA County.

Duration: Approximately 1 year and a half.

- Achieved the highest smart meter opt out rate in Edison territory (unofficial record per Edison utility staff) by organizing local community and doing a mass mailing to 8,500 people in the town making them aware of the biological dangers and health effects and privacy invasion from smart meters.

Duration: Approximately 1 year.

- Over the years, through our non profit, <https://thepeoplesinitiative.org/> we have helped thousands of EHS (electrosensitive) people, or just people who were experiencing health effects from their smart meters, cell towers, WIFI or other wireless devices and infrastructure and didn't know how to protect themselves, how to cut down their exposure or how to take legal action. We have also helped people who did not want their right to privacy in the home taken from them with regards to the smart meter roll out and who were systematically and automatically over billed due to their smart meter.

Duration: Ongoing.

- Through the non profit, have given countless power point presentations to communities, government agencies and schools on the issue of health effects from wireless devices and infrastructures and have testified at numerous governmental hearings as an expert witness on health effects from wireless devices and infrastructures.

Duration: Ongoing

- Outside of the non profit, helped organize and attended multiple protests against smart grid, one of which gained media attention because unbeknownst to us, ex US Vice President Al Gore owned the smart grid company we were protesting.

Duration: months

- Through the non profit, initiated, helped organize and raised partial funding (2015 – 2018) for a ground breaking study with Dr. Gunnar Heuser that shows pictures of EHS/electrosensitivity on an fMRI (functional MRI). FMRI measures brain functionality as opposed to MRI which shows objects (tumors) in the brain. This is the first known published study to make the invisible EHS, visible by showing it in pictures from the fMRI. This study will be used in civil and possibly criminal proceedings against the wireless industry and government as documentation that wireless radiation exposure does affect the brain and that EHS is real.

Duration: Ongoing including helping find another medical facility, scientist and cases for replication of the fMRI/EHS study, plus a new epidemiology study on

wireless radiation and health effects we are doing with Dr. Heuser. Our focus at this moment is on producing studies to help our lawsuit and others like it on EHS and human rights violations, win in court.

The brain on the left (the case) in the above fMRI picture is mine.

Note: It's important to remember that wireless radiation exposure also affects other cells and organs in the body besides the brain.

- Filed a lawsuit against the City of Santa Monica for violating the ADA (Americans with Disabilities Act) regarding not allowing for hard wired Ethernet access and forcing the use of WIFI in buildings of public sponsorship such as the city library. (2016 - current) No attorney would take the case so I sued pro per se, or representing myself against the city. The city actually offered to mediate and settle. However part of the settlement would be to gag me about the lawsuit and seal the court records. Thus I refused the settlement. The case ended up having to settle anyway due to unforeseen circumstances with the attorney who was helping me with the legal briefs and filings.

Duration: approx 3 years.

- Started filming a documentary on this subject in 2007. The film started out as one thing, but has changed over the years as I acquired more knowledge (and first hand experience) of EHS and as the plethora of cover ups unveiled themselves – which I'm sure are only the tip of the ice berg, but there is an ice berg there and we plan on exposing as much of it as possible with our film.

Duration: approx. 12 years – aiming at wrapping production by end of 2020 with God's help.

- Between 2018-2019 Liz studied at the Building Biology Institute and passed all the courses for Electromagnetic Radiation Specialist, with only her final project left before certification.
- Currently - Started lawsuit against FCC regarding 5G, ADA, Fair Housing Act, non thermal effects from wireless radiation and Constitutional violations of the Telecom Act. This lawsuit will be most likely be filed in early 2020. One of the law firms involved is the firm that took down PG&E from the Erin Brockovich film.
